June Deal Memorial Scholarship

Minimum Eligibility Requirements

Applicants must be a resident of Elkhart County for a minimum of one year and be planning to pursue a 4-year Bachelor degree at an accredited college or university.

Per the wishes of the original donor, the scholarship will be awarded to a first-generation college student whose parents (biological parents, adoptive parents, or legal guardians) have not attained an advanced degree (associate degree or higher). Traditional (HS Senior) and Non-traditional (Adult) students are eligible to apply

Selection Criteria

Selection will be based on participation in Trinity on Jackson activities, academic achievement, and the required essay.

Holcomb Family Scholarship

Minimum Eligibility Requirements

Applicants must be a High School Senior who is a resident of Elkhart County for a minimum of one year and is planning to pursue postsecondary education at an accredited two- or four-year college or university. If selected for scholarship can reapply in the future.

Selection Criteria

Selection will be based on participation in Trinity on Jackson youth activities, academic achievement, demonstrated financial need, and the required essay.

Jeffrey Poorbaugh Memorial Scholarship

Minimum Eligibility Requirements

Applicants must be a High School Senior who is a resident of Elkhart County for a minimum of one year and be planning to pursue postsecondary education Full-Time at an accredited two - or four-year college or university.

Eligible Fields of Study are

- Electrical Engineering
- Trade/Vocational School study of Electronics
- Computer Technology

If selected for scholarship can reapply in the future.

Selection Criteria

Selection will be based on participation in Trinity on Jackson activities, academic achievement, and the required essay.

ALL applications must include the following documents:

1. **Essay** (1 page maximum, double spaced) addressing your involvement with Trinity on Jackson and/or Trinity youth programs and why it was important to you.
2. One **photograph** of yourself (will not be returned) to be used in internal and external promotion and publicity if you are a scholarship recipient.
3. A copy of your official **high school transcript**.

For Deal Scholarship and Poorbaugh applications:

Additional Essay (1 page maximum, double spaced) describing your aspirations and educational goals.

Non-Traditional Applicant: Non-traditional applicants should provide their most recent college or high school transcript.

For Holcomb Scholarship applications:

Copy of your **Estimated Family Contribution from the FASFA**. If the FASFA evaluation has not yet been received, you may provide a printout of the information from <https://fafsa.ed.gov/FAFSA/app/f4cForm?execution=e1s1> showing your EFC.

Please circle the scholarships you are applying for. *In order to be considered for any scholarship, you MUST submit the necessary documents.*
